Payment:

Full payment of invoice is required to secure the booking.

Cancellation:

Any cancellations must be conveyed in writing to vklooflodge@telkomsa.net

- 100% will be refunded if cancelled 30 days prior to function
- 50% will be refunded if cancelled 29-14 days prior to function
- 0% will be refunded if cancelled 13-0 days prior to function

Refunds will be processed 7-14 working days from receipt of written cancellation.

Terms & Conditions:

- The client is entitled to 2 hours exclusive use of the venue from either 10:00-12:00 or 14:00-16:00.
- Toys and entertainment must be supplied by our preferred suppliers.
- Once your time slot has expired, the venue must be vacated within 30 minutes, failing which, R1,000.00 will be charged for every half hour thereafter.
- Number of adults, number of children, any dietary requirements and any other special requirements must be conveyed in writing no later than 10 days prior to the event.
- Strictly no driving of nails or other sharp items into walls. Décor to be affixed onto walls with sellotape or prestick only.
- Lodge's responsibilities: to provide a clean venue, tables & chairs for 40 adults and any items that were marked off on appendix 1. Only items confirmed in writing will be supplied.
- Vredekloof Country Lodge is fully licensed. Corkage of R50.00 per bottle (wine or sparkling wine) will be charged for any wine or sparkling wine brought onto our premises (please contact us for corkage pricing for hard liquor).
